## BRUNSWICK ROAD ALLOTMENTS

The proposal by Ealing Council to build housing on just over one acre of the allotment land between Neville Road and Brunswick Road was discussed at the Society's AGM last November and described in detail in our Newsletter No. 22. It may be recalled that the proposal arose out of a policy document on the subject of leisure gardens, which considered that there was excess allotment land in this area and that part of the surplus land could be used for housing.

Two aspects of the proposal have recently caused fresh concern: (1) a suggestion made in the Housing Committee that it would be desirable to take more than the acre of ground originally proposed; (2) the view of the Planning Department that it may prove necessary to demolish two houses in Neville Road to provide access to the site.

The Committee of the Brentham Society is opposed to these proposals for the following reasons:

- 1) We consider that the outer London boroughs should not be pressed by the GLC to house more and more people from Inner London, many of whom are being ruthlessly displaced by commercial redevelopment. It would be better to rectify the cause rather than attempt to alleviate the effects.
- 2) Ealing Council is naturally anxious to do something for its own homeless or inadequately housed people. The continued drift of population to London and the South East is likely to swell this number. Great care should be taken by the planning authorities to ensure that the demand for housing is not met at the expense of minimum standards of open space, with irrevocable damage to the environment.
- 3) This part of North Ealing is already subject to a considerable increase in population, as large Victorian houses are replaced by flats (e.g. in Mount Avenue); this will put an increasing strain on services in the area and additional housing land should not be sought in this area.
- 4) The Borough of Ealing needs to preserve all its open space; it is fifth in population in the London boroughs, yet fourteenth in open space. If the present proposals are carried out, allotment land in the borough will fall below the minimum of  $\frac{1}{2}$  acre per 1,000 population which was recommended by the Thorpe Report on Allotments in 1969.
- 5) It has been said that the allotments on this site are underused. We suggest that this is because their use has been discouraged by planning proposals over several years and also by the Council's refusal to plough the vacant sites.
- 6) The Brentham Garden Estate has been designated a conservation area by Ealing Council, which in its own report on these areas in 1969 stated: "They (the conservation areas) depend on the existence of open space and once this open space is developed it will not, for any practical purposes, ever be available for open space again."
- 7) We are completely opposed to the demolition of any houses on the estate; in particular, the two houses in Neville Road which are threatened (those facing Meadvale Road) form one of the focal points and provide an attractive boundary at this corner of the estate.
- 8) Any new development would be unlikely, because of the cost, to be in sympathy with the present character of the estate. In addition, more traffic would be generated which could be detrimental to adjacent roads (Denison, Meadvale, Brunner, Neville and Ludlow).

ACTION: Those who have written to the Chief Town Planning Officer have been informed that they will be able to comment on the proposals when the formal planning application is made. We think it essential that the views of residents should be made known now, before final commitments are made. The Committee is writing on

behalf of the Society to all those listed below and is proposing to circulate in the near future a joint protest which all residents may sign. Anyone wishing to write an individual letter should of course do so.
